1.	/elcome and apologies	
	Alan Wilson welcomed everyone to the meeting and the above apologies were noted.	

2.	Minutes from previous meeting of 20 th April 2023 and matters arising:
	The minutes of the previous meeting were confirmed as accurate. John Hutchison requested a change to the minute:
	In 2021 a feasibility study was undertaken at Blar Mor and concluded there was potential to relocate a helipad suitable for performance 1 and 2 helicopter operations however it was emphasised that until the hospital site plans including building heights were finalised further work regarding the landing site concept, development plans and construction should not take place. As soon as this information is available CAA will advise on the final helicopter landing site location. JH suggested that NHSH should forward a drawing that showed the maximum possible size of a hospital on the site to allow CAA to assess its potential without delay. HC agreed to do so.

3.	Update on progress since the Crosscheck Workshop on Tuesday, 18th April – Louise Bussell / Alan Wilson
	Alan confirmed the project board will meet on 23 rd May review the development, clinician/team member sign off, clinical output specification and scheduled accommodation, clarify the agreed service models for the hospital in line with option 3 & 4 of the initial agreement and in advance of the stakeholder engagement on 6 th June.
	A pre meet for the Lochaber Stakeholders will take place on 6 th June at 11am – 12 noon, with some flexibility on time, the open public event is from 1pm – 6pm. A stall will be in place to enable discussions with wider community stakeholders.
	At the stakeholder event on 6 th June there will be a display of each current department, services for the future and highlighting the changes. John Gillespie asked if this information could be confirmed before the event, Alan confirmed this may be a possibility.
	A paper outlining a number of recommendations for extra resources will be taken to the project board.
	Alan confirmed Balfour Beatty are discussing various aspects of the project including, pre-construction, health & safety, net zero and strategies to ensure all is in place for development once sign off has been agreed.
	Alan confirmed the challenges with accommodation for staff and the ongoing discussions with council colleagues.
	David Sedgewick asked for clarification on the provision of an HDU in the new hospital. John Hutchison asked for clarification on intensive rehab. Alan confirmed the model of services will be discussed at the 6 th June event and described the work that has taken place to cross check the proposals with the agreed IA.
