2 Report summary

2.1 Situation

The Health and Social Care Committee has previously, over the course of 2021-2022, considered the role and remit of the Adult Social Care Fees – Commissioning, Briefing and Instruction Group.

The report firstly updates on the current fee setting process and status and then offers recommendations for the Committee's consideration, to both address time sensitive fee and contract sign off arrangements for 2022-2023, and also address the role and remit matters highlighted by the Committee at previous meetings.

2.2 Background

NHS Highland annually considers fee levels and the contractual arrangements that will apply to commissioned adult social care services for the following financial year. These services include care home, care at home, support and day care services, which equate to over 250 contracts and over £95m in value.

An agreed process is undertaken annually, in accordance with the remit previously agreed by the Health and Social Care Committee, which is then reported back to the Committee to provide assurance around this area of activity.

2.3 Assessment

2.3.1 Fee Rates 2022-2023

The setting of adult social care fee rates is undertaken on a fee category basis, which means that where fees and contract extensions are set, there is a unified approach across that category.

The fee rate approach applied for 2021/2022 is provided below:

The process of reviewing adult social care fee rates is based on a number of elements, a crucial component of which is the outcome of the National Care Home Contract (NCHC) national negotiations and settlement. In respect of 2022-2023, these are unlikely to conclude before the end of March 2022.

In addition, and now for the last two financial years, the Scottish Government has also provided clarification and direction for fee uplifts to non residential contracted services.

These two key areas (NCHC approach and SG direction) therefore inform the fee approach to be applied to specified fee categories and influence the fee approach applied to most other fee categories.

The process of fee setting for 2022-2023 has not, at the time of writing this report, been finalised. The NCHC settlement outcome is awaited and there is a need for

necessary clarification and analysis before recommendations can be offered and considered within the due process.

In respect of the 2022-2023 financial year, NHS Highland is aware that the Scottish Government has confirmed a minimum rate of pay of £10.50 per hour for staff providing direct care within Adult Social Care commissioned services, but associated detail and application is awaited and imminently expected.

Particularly in the current context of adult social care recruitment and retention pressures, it is critical that timely assurance is provided to care providers regarding forthcoming fee rates, to enable staff awards to be confirmed and made. This is a crucial action to promote sustainability in commissioned provision, which is a current Scottish Government and NHS Highland priority in order to continue to access current, and also additional, capacity.

Accordingly, to ensure service continuity and for providers to be notified of fee rates for 2022/23 and contract extension, there is a need to communicate fee award decisions to providers, where at all possible, before contract expiry on 31 March 2022, in order to avoid a contractual gap and associated risks.

At the stage of drafting this report, the required Scottish Government confirmations and NCHC clarifications have not yet been received to enable inclusion in this report for committee consideration and approval, and the timing of the next meeting of this committee is such that it would present a delay in provider notification.

In order to address the need for both timeliness and also the governance matters previously considered by this Committee (and as referenced below at 2.3.2), the Committee is requested to consider the following:

a) to agree to a delegated mandate for a joint decision on annual fee and contract arrangements to be made by the Chief Officer and Director of Finance, aligned to the imminent Scottish Government and NCHC requirements and agreed financial plan, for 2022-2023 to ensure service continuity and sustainability, thereafter providing an assurance report to this committee. In the event of any recommended or proposed uplift beyond and not aligned the Scottish Government requirement, this would necessitate approval being sought from this Committee.

or

b) to **agree** to establish a sub committee of the H&SCC, with a single item focus in relation to fee and contractual matters, in order to consider and agree annual fee rate and contract arrangements, at the appropriate time in the financial year; and if minded to agree to the establishment of such a sub committee, to consider and **agree** appropriate membership to enable the convening of this committee during March / April 2022, as required.

With regard to Third Sector activity, the current position is as noted within an **Appendix B**, which is to follow.

2.3.2 Adult Social Care Fees – Commissioning, Briefing and Instruction Group Role and Remit

The current role and remit for the Adult Social Care Fees – Commissioning, Briefing and Instruction Group was last reviewed in December 2019. An updated role and remit was presented to the Highland Health and Social Care Committee on 30 June 2021 to reflect updated governance structures and group membership.

In its consideration of this report, the Committee requested further amendments to the proposed governance routes.

A further update was subsequently provided in the Chief Officer's assurance report for the Highland Health and Social Care Committee on 2 November 2021 meeting, which referred to the need to revise the role and remit for the Adult Social Care Fees Briefing and Instruction group, to take account of the request of this committee to undertake a sign off role in respect of annual fee and contract arrangements.

However, the committee's consideration of the approach to the area described at 2.3.1 above, will clearly link to and impact on, the committee's preferred approval arrangements in terms of the role, remit, governance and sign off arrangements.

It had been intended to present a final role and remit, but given the request set our earlier in this paper, this has been currently drafted to take account of the noted two options, and will be updated accordingly to reflect the committee's agreed (or alternative) preference. The role and remit currently drafted by way of this described approach, is set out at **Appendix B**.

It is also highlighted for information, that the full range of described remit within the attached has not been fully met over the course of the last 18 months, due to the continued redirection of resource to the Adult Social Care Covid-19 response. This is an area which is being addressed as a priority and an update on this matter will be provided to the next meeting of this Committee.

Adult Social Care Fees – Commissioning, Briefing and Instruction Group DRAFT Role and Remit 3 March 2022

Background

NHS Highland contracts with care providers, paying agreed fees for the care services provided. Depending on circumstances, these fees are either *standard* fees which are overseen by the National Care Home Contract, or non-standard fees which recognise a specialist service which usually manages a level of complexity.

The Adult Social Care Fees – Commissioning, Briefing and Instruction Group (Fees Group) was established in 2017 as an operational group to ensure consistency of approach across the North Highland Partnership area.

The remit of the Fees Group was agreed by the Health and Social Care Committee in March 2018 with a further update in December 2019 which consolidated the already agreed role and remit and provided further detail as to the operating procedures of the group. A revision in June 2021 was made to the membership and fee sign off process.

This further revision in February/March 2022 is to update the fee governance process to clarify assurance and oversight.

The Adult Social Care Fees – Commissioning, Briefing and Instruction Group

The required oversight will be provided by an Adult Social Care Fees – Commissioning, Briefing and Instruction Group (Fees Group). Approval of this group is required to progress to any adult social care commissioning / procurement arrangement and this group will oversee contract performance.

<u>Remit</u>

The remit of this group will be to oversee, consider and agree recommendations and provide instruction on **North Highland** Adult Social Care Commissioning financial tariff, contract and activity issues to ensure compliance with current Standing Financial Instructions.

The group will:

- consider Adult Social Care Commissioning related issues;
- provide instruction to Commissioning / Procurement Teams;
- oversee the Adult Social Care contracts register;
- monitor and receive reports on Adult Social Care Commissioning activity;
- identify and report on areas of non compliance;
- prepare annual fee and contract recommendations to the Chief Officer and Director of Finance to ensure the approach represents the NHS's agreed strategic direction; meets the Board's objectives; and is affordable.

- thereafter, submit annual fee and contract recommendations for approval to the Highland Health and Social Care Committee, or delegated sub committee as appropriate;
- consider, agree and implement any mid year, or out of course, Adult Social Care fee related matters, and in doing so, ensure consistent, equitable and transparent consideration and decision making and within a mandate agreed by the Health and Social Care Committee, or delegated sub committee as appropriate.
- prepare annual (or more frequently or outwith this schedule if required) financial and contract recommendations.
