1. Previous notes

Newsletter

Marie shared the easy-read newsletter with those present and advised the easy-read version was created based on guidance that was received from internal experts. The information that was in the main newsletter has been condensed into easy read and key content has been used to create the new version.

Requested changes

requested there be an option for feedback to be provided back to Sophie.

Marie reminded the group the newsletter is available in accessibility mode meaning the format of it can be changed and call also be read out to people. There will also be a small number of hard copy of the newsletter available to be distributed around communities.

Marie asked Caroline and Ross to give suggestions on where to display posters and distribute the newsletters. Caroline offered to distribute some newsletters and posters and requested these would be posted to her. Caroline reminded the group that laminated posters would not be appropriate for people with visual impartment.

AOCB

Caroline sought further information about the NHSH Near me and Telecare service. She shared examples where people did not have the right equipment to use the service and who had to travel instead. The group discussed and agreed that information about support available to people would be helpful. This could be via AbilityNet, a national community organisation that supports people in their own home, to access and use digital equipment. Ross felt that Skye labs may also be able to provide support to local people.

Caroline reminded everyone that information about services should be available in different formats and places, to make sure they are accessible for people who do not have access to or use the internet. etc.
