- Signs of financial harm can vary, but could include things you see or hear about the
  adult and their financial situation. You might notice that an adult you know is
  struggling to pay their bills when previously it was not an issue. You might be
  concerned that there is less food in the house. You may be suspicious that someone
  known to the adult is not acting in their best interests regarding their finances.
- Adults who have to rely on others for their care, can be especially at risk of being financially harmed.
- In cases reported to Hourglass Scotland over the last 3 years, concerning financial harm more than two million pounds has been stolen or defrauded from older people. The real total amount, will be many times that figure across Scotland over recent years. In 60% of the cases the person who was financially harming the adult, was a family member or partner 37% of them were sons and daughters.

#### **Level 1 Training**

Please note this training is intended for the following staff groups – Please ensure you are booking the correct training course:

- NHS Band 1-3
- Highland council Grade 1-4 or equivalent for other organisations

Job roles may include for example - Social Care Assistants, Healthcare Assistants, Social Care Workers, Domestic Staff in hospitals / care facilities, Care at Home Workers, Emergency Services workers

If you are NHS Band 4+ you are NOT required to book a level 1 course prior to attending Level 2 training

#### **Level 2 Training**

Please note this training is intended for the following staff groups – Please ensure you are booking the correct training course:

NHS Band 4+ Patient Facing

Highland Council Grade 5 + or equivalent for other organisations

Job roles may include for example - Nursing or Midwifery Staff; OTs; Physiotherapists or other Allied Health Professionals; Managers, Team Leaders or "Senior" roles; Social Workers or Social Work Assistants; GPs, Dentists or other Medical professionals; Advocacy workers; Fire Service (role dependent).

If your job is within the criteria above, you are **NOT** required to complete the trainer led level 1 course before attending, please complete the NES Adult support and protection : practice level 1 [informed] E-Module (on TURAS).

**Level 3 - Training** 

**Council Officer/Nominated Officer - Dates will soon be available for 2025 on Turas -** This level is for the following groups: Council Officers (or social workers with 1 year of practice experience looking to undertake CO role), Nominated Officers (or those wishing to undertake NO role as outlined in interagency procedures).

**Crossing the Acts Training** - We are hoping to have our 1st session in March 2025 with a few sessions planned for the remainder of the year. This session will be delivered by ASP, AWI and MH team members.

**Investigative Interviewing** - We are working on getting this training ready for deliver, please keep an eye in the newsletter for updates.



## **SIPP Training - Suicide Intervention and Prevention Programme**



This programme is now being delivered as either an online or face to face course by approved Suicide Prevention trainers. The training has been split over 2 x 2hrs sessions for online or 4 hrs face to face.

The programme was originally developed in Tayside and complies with Health Scotland's requirements of suicide prevention training.

#### Who is the training for?

Any staff who want to be able to help someone who might be at risk of suicide.

#### **Brief Outline**

About Suicide: the scale of the problem, facts and myths, risk factors, attitudes, and stigma

How to help: recognising the signs, how to ask and listen in a supportive way, keeping the person safe.

Resources: Available resources and where to Signpost people to for help..

Case Study: group discussion, identifying risk factors, how to help.

#### What will I learn?

The ability to recognise a person at risk of suicide.

The ability to ask about suicide including the ability to display listening and questioning skills.

An awareness of the impact of attitudes on suicide.

Resources available and how to signpost to appropriate support.

#### To apply:

NHS Highland staff can book onto a SIPP course through Turas Learn. You can find details of the courses and book onto them on the NHS Highland Public Health Zone and selecting Suicide Prevention'.

'Five Nations' Adult Support, Protection and Safeguarding Seminar Series,



Friday 14th of February 10-30am-12.30 pm

"After the Cawston Park Hospital tragedies of 2019- 20: implications..." This seminar will briefly explore what happened - and what has happened since in Norfolk.

**Background**: During April 2019, Norfolk's Safeguarding Adults Board ("NSAB") commissioned a Safeguarding Adults Review (SAR) concerning the deaths of two adults at a private hospital, Cawston Park. During December 2020, the death of a third patient was added to the review's remit. The deceased, Joanna, "Jon" and Ben were in their 30s. They had learning disabilities and had been patients at the Hospital for 11, 24 and 17 months respectively. They died between April 2018 and July 2020.

# Invitation to SIAA Independent Advocacy Event: Social Finance & Henry Smith Report

<u>Scottish Independent Advocacy Alliance (SIAA)</u> are delighted to invite you to our upcoming webinar. It is an opportunity for stakeholders in Scotland to gain an understanding of the value and impact of independent advocacy.

You can sign up for the webinar which will be hosted via Teams on Tuesday 18 March 2025, 2pm - 4pm.

#### **Background and more information**

The event will focus on the upcoming report titled "Independent advocacy for independent lives", by <u>Social Finance</u> and the <u>Henry Smith Charity</u>, due to be published in February 2025. You'll hear about the key findings and recommendations from a pioneering £2.6m Strategic Grant programme funded by Henry Smith Charity, where Social Finance built evidence as the learning and evaluation partner.

Between 2022 and 2024, the programme supported 1,667 people with learning disabilities and autistic people, by funding 15 grantee organisations across the UK to provide independent and non-statutory support. Without this support many may have found themselves in crisis, leading to high levels of engagement with statutory and crisis services, while for every £1 invested, £12 in savings was made for the state (£7 for the NHS, £5 for local authorities).
