2 Report summary

2.1 Situation

The National Treatment Centre Highland (NTC-H) is part of a national network of 10 treatment centres funded by the Scottish Government. The Treatment Centre Programme aims to provide additional hospital based diagnostic and treatment capacity within Scotland.

Construction of the NTC-H commenced in the summer of 2020 and at the time of writing this report we are in week 96 of the construction programme

Following the last update to the board it has become clear that there will be a further delay in completing the construction of the facility.

The construction timetable has been adversely impacted due to the following key issues:

- Delays with delivery of plasterboard materials, roofing material, and steel.
- Delays with concluding the technical detail of the theatre layouts including preferred positions of equipment,
- Impact of Covid infection and isolation periods on productivity.

2.2 Background

The NTC-H will provide,

- Uncomplicated hip and knee replacement surgery,
- hand, foot, and ankle surgery
- A full range of ophthalmic care including outpatients and surgical treatment

The facility will have,

- 24 beds (3 flexible use for ophthalmic patients)
- 5 operating Theatres
- 13 consulting rooms (Inc 2 teach treat and 4 virtual consulting rooms)
- A full range of ophthalmic diagnostic and treatment services

· A patient / staff café

A detailed workforce plan has been developed in conjunction with operational and clinical colleagues and validated externally and via the National Treatment Centre Programme Team. An additional 210 staff will be recruited across a range of clinical and operational roles to support the delivery of the new service

2.3 Assessment

The construction programme has been impacted by events such as material supply constraints, absence of sub-contractor operatives due to Covid-19 isolations since June 2021 and completion of detailed theatre designs. It is now apparent that the contract completion date will not be achieved, and a new contract completion date will be agreed with Balfour Beatty.

Efforts to mitigate the impact of delays have managed to reduce the overall impact of the delays however the forecast completion date is now 09th December 2022 and it is unlikely that this date will be improved upon.

This delay will have an impact on the clinical transition plan, and the 'first patient treated' is now expected to be Monday 3rd April 2023.

There remains considerable pressures in the construction industry, relating to the delivery of materials which are challenging to mitigate.

Whilst every effort will be made to deliver against the revised programme of works, there are significant activities to be undertaken and as such we cannot rule out the potential for further programme slippage between now and the forecast completion date.

The project team continue to work collaboratively to manage the delays in line with the contractual processes, and any further delays will be communicated to the NTC-H Project Board.
