Thank you for supporting the official charity of NHS Highland.

Did you know you can increase the value of your gift to the Highland Health Board Endowment Fund Charity by 25% at no extra cost to you simply by completing a Gift Aid declaration?

As a registered charity, we can reclaim the tax on your donation from HMRC through the government's Gift Aid scheme.

How it works

If you pay tax in the UK, every £1 you donate allows us to claim an additional 25p.

For example, a £30 donation could be worth £37.50 to us, **at no extra cost to you**, just by filling in a short form. We can claim Gift Aid on:

- Donations you have made in the past four years, and
- Any future donations you make.

Gift Aid will not affect your tax status. However, please note that we can only claim it on personal donations made by UK taxpayers—not on behalf of another person, a group, or from a collection.

How to make a declaration

If you donate online or through our <u>JustGiving page</u>, you'll be prompted to complete a Gift Aid declaration as part of the process.

If you'd prefer a paper form, just let us know—we'll post one to you.

Keeping your details up to date

Please tell us if you:

- · Wish to cancel your declaration,
- Change your name or address, or
- No longer pay sufficient Income or Capital Gains Tax.

If you are a higher-rate taxpayer, you can also claim personal tax relief through your Self-Assessment tax return or by asking HMRC to adjust your tax code.
